ANNUAL REPORT 2018/19 Advancing SES Volunteers through National Representation and Advocacy



NSESVA - The Beginning

In the late 2000s, some SES Volunteers discussed setting up a National body to represent the SES Volunteers.

At the 2012 AFAC Conference in Perth, a small group of SES Volunteers from WA and NSW, gathered behind some partitions and had a chat about when, where and how. The SES Volunteers were Peter Lalor, Gordon Hall, David Price, Dave Beard, John Capes, Charlie Moir and one other.

The then NSW SESVA Chair, Charlie Moir ESM, pledged support from the NSW SESVA to assist and provide some funding to make this happen.

A working group (NWG) was set up in 2013 consisting of SESVAs from NSW, Victoria, ACT, South Australia and Western Australia.

The NSW SESVA became the lead agency for the NWG, and all meetings were chaired by Charlie Moir ESM, President NSW SESVA. Documentation for meetings was provided by the NSW SESVA, including arranging accommodation, preparing agendas, supporting papers, preparing meeting notes, information, recording and distribution of Minutes.

Qld and the NT joined the working group in 2014.

Tasmania joined the National Association in mid-2018.

At the working group meetings, a number of ideas were tabled and discussed with agreements on;

- Objectives of the future Company,
- Structure and voting,
- A National Council to be formed

The Board of Directors were originally restricted to association Presidents and later modified to include an

independent Director and Chair.

Councillors were provided by each Association (one each). They were required to enter into discussions with the Board and its members and were assigned projects together with Board members.

It was intended that these would be representative of the relevant associations' members and were not to be

paid association or agency employees.

The constitution was discussed and eventually submitted.

Other items such as funding, raffles, and preparation of documents to compare the different states and territories were discussed at these working group meetings.



NSESVA - The Beginning (continued)

In May 2015, the NSESVA was officially formed as a Company, with the Registered Office, required consents, ACNC registration and other administrative matters all being completed.

Directors and Councillors were assigned specific projects and reported progress at each meeting.

Many of those projects will always be ongoing and the Directors will continue to work at those national tasks.

A succession of changes were made to the constitution to meet the changing needs.

The registration of the Association as a limited liability, not-for-profit company, also facilitated taking over the income-generating raffle that NSW SES VA had used, not only to fund itself but also our association through its formation process, enabling the national association to generate income across the nation.



Chairman's Report - Gordon Hall ESM

During this fourth year as a National Board, there have been a number of changes and achievements, some well recognised and others quietly happening in the background. The Board has worked hard and operated well as a team showing the mutual respect and acceptance of members, their opinions and personal Circumstances.

Change in Chairman

In August 2018, the then Chairman, Charlie Moir ESM, stepped down from the Board and we had a change in leadership. Charlie was presented with a special plaque honouring him as the *Inaugural Chair* of the NSESVA.

It is a credit to the Directors and Councillors that there was no disruption to the business during this change.

Administration

The Board had in previous years developed the NSESVA Business Plan, however this year, two documents were developed by the executive group from supplied information to assist the Board members.

The *Operating Plan* was a guide on roles and meeting dates of the NSESVA, whilst the *Jurisdictions Structures* paper provided details on structures and numbers in all jurisdictions.

Representation on External Committees

NSESVA Board members have been actively involved in a number of AFAC committees including, Volunteer Management Technical Group, Fitness for Role Project Team and the Volunteer Impact Assessment Guideline Doctrine Proposal Review. The other committees include the BNHCRC Adapting the Sector Advisory Group and the Australian Emergency Management Volunteer Forum.

Raffle Fund Raising

The raffle fund raising administration and governance was not at the standard this Board required and since the change in accountants, we have been able to correct a number of errors and lags in payment as we move to a best practice.

The raffle dollar value in sales has increased by 14% over the 2018/19 financial year which will give us a bench mark for the future.

The auditor has provided guidance and has been very supportive and positive about the administration of the raffle.

Youth Involvement

The Board is to be commended for developing an initiative for SES youth members to travel to Canberra for the national memorial service.

The inclusion of a tour of Parliament House, tour of the ACT SES facilities, sitting as observers at a National Board meeting and then participating in the special dinner was greatly appreciated by all.

The feedback and acknowledgement by other agencies has been very positive.



Chairman's Report - Continued

National Emergency Services Memorial Service

The involvement of the NSESVA in the annual memorial service is a great opportunity for all Board and Council members to meet and attend this service.

The SES contingent was well received, and it gave a great opportunity to network across other emergency services and agencies.

The inclusion by AFAC of the eight SES Youth members from around the country, as a guard of honour for the official party and assisting family members in finding names on the plaques, was seen by many of the Emergency Service leaders and representatives as a very positive initiative by the NSESVA.

This will lead us to next year, with a little more time for planning and to improve the process.

The Future

The NSESVA has a bright future as the Board members, Directors and Councillors, show initiative in areas that need to be addressed, with new ideas and energy, such as the youth initiative, which the Board has determined will happen again next year.

The AFAC19 paper and presentation on "Women in the SES" being presented by Board members Faye Bendrups and myself in August 2019, I am sure will start a conversation amongst some agencies.

In closing I would like to say that this has been a very busy year as the Board is still forming and determining where it can make the most positive affect on the State Emergency Service, the SES Volunteers and the Communities we all serve.

I thank all the Directors, Councillors, and our supporters for all their hard work and support.

Highlights

Membership

The period 2018/19 saw the strengthening of the Association with all eight state and territory Associations working closely together for the betterment of the 28 000 State Emergency Service Volunteers across the country.

This is a great achievement for all SES Volunteers to be represented and recognised Nationally.

Fundraising

The Association commenced fundraising by running raffles with OneContact in November 2016. The 2017 – 18 year saw some states/territories join the fund-raising program and although slow in some areas, it will gradually increase.

The National Association directs funds raised in each State or Territory back to that State or Territory and is keeping a watching brief over the conduct and profitability of these raffles.

SES Youth Contingent at the National Emergency Services Memorial Service

The Board decided to bring an SES youth Volunteer from each jurisdiction to Canberra to attend the memorial service.

During this visit they attended an NSESVA National Council meeting as observers, had a tour of Parliament house, a tour of the ACT SES facilities and were part of a special dinner in their honour.

Their participation at the Memorial Service was well received and the Association and SES has been well recognised for this initiative.

Representation

The Australian Emergency Management Volunteers Forum was moved to the Home Affairs Department in 2018, and then moved on to AIDR in July 2019 as it was a better fit. NSESVA Chair, Gordon Hall ESM, is the SES representative and has attended all meetings of the Forum.

As an Associate Member of the Australasian Fire and Emergency Services Authorities Council, Dr Faye Bendrups represents the NSESVA on the Volunteer Management Technical Group, SES Fitness for Role Steering Committee, AIDR Dranzsen Forum, BNHCRC Advisory Group and the AIDR Spontaneous Volunteer Handbook Working Group.

The Board of Directors continued their annual attendance and laying of a memorial wreath at the National Emergency Services Memorial held in Canberra.

The NSESVA continues its alliance with the Australian Volunteer Fire Associations (CAVFA).

Structure


The National State Emergency Service Volunteers Association is a coalition of each State and Territory Volunteers Association.

A Board of Directors oversees the operation of the organisation. The President (or equivalent) of each State and Territory Volunteers Association is appointed as a Director of the organisation. The positions of Vice Chair and Secretary/Treasurer of the National Association provide leadership to the Board in formulating strategy, policy, risk and financial management.

Each State and Territory may also nominate an independent representative from their own State or Territory Association to become a member of the National Council. These representatives and the Board form the National Council. The National Council considers, researches and makes recommendations to the Board on issues that are relevant to State and Territory Emergency Service Volunteers.

The Chair, Vice Chair and Secretary/Treasurer are elected by the National Council and they form the executive group to take care of the day to day business.

No person may serve for more than six (6) years in a position.

1. Reporting entity

National State Emergency Service Volunteers Association Ltd ("the Company") is incorporated and domiciled in Australia as a company limited by guarantee. The address of the Company's registered office is Unit 1/2-6 Lindsay Street, Rockdale NSW 2216.

The financial statements of the Company are as at and for the year ended 30 June 2019.

The principal activities of the Company are to consolidate and represent the views of the members of National State Emergency Service Volunteers Association Ltd in dealing with its members, the Government, media and the general public and to support the development of the organisation nationally to support SES volunteers.

Basis of preparation

(a) Statement of compliance

National State Emergency Service Volunteers Association Ltd applies Australian Accounting Standards – Reduced Disclosure Requirements as set out in AASB 1053: Application of Tiers of Australian Accounting Standards and AASB 1010-2: Amendments to Australian Accounting Standards arising from Reduced Disclosure Requirements

The financial report is a general purpose financial report which has been prepared in accordance with Australian Accounting Standards — Reduced Disclosure Requirements and interpretations issued by the Australian Accounting Standards Board ("AASB"), the Corporations Act 2001. The company is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

The financial statements were approved by the Board of Directors on

2019.

(b) Basis of measurement

The financial statements have been prepared on the historical cost basis.

(c) Functional and presentation currency

The financial statements are presented in Australian dollars, which is the Company's functional currency.

(d) Use of estimates and judgements

The preparation of financial statements in conformity with AASBs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in any future periods affected.

Information about critical judgements in applying accounting policies that have the most significant effect on the amounts recognised in the financial statements and assumptions and estimation uncertainties that have a significant risk of resulting in a material adjustment within the next financial year, are included in the notes to the financial statements.

3.

Significant accounting policies

The accounting policies set out below have been applied consistently to all periods presented in these financial statements, which addresses changes in accounting policies.

(a) Going concern

The financial statements have been prepared on a going concern basis, which contemplates continuity of business and the realization of assets and settlement of liabilities in the ordinary course of business.

The Company has recorded a surplus of \$5,094 for the year ended 30 June 2019 (2018: loss of \$311,889), total accumulated loss of \$163,952 (2018: \$169,046). The working capital deficiency amounted to \$83,952 (2018: deficiency of \$89,046).

The ability of the company to remain as a going concern is dependent on the following:

The company achieving its forecast results in order to enable them to generate sufficient cash flow to
maintain its operations, and growth of revenue in States and Territories which have had a lower uptake for
donations historically.

After reviewing the forecast cash flows, the directors of National State Emergency Service Volunteers Association Ltd consider the company will continue to fulfill all obligations as and when they fall due for the foreseeable future. The Directors believe the cash flow required is achievable and accordingly consider that the company's financial statements should be prepared on a going concern.

Accordingly, no adjustment have been made to the financial statements relating to the recoverability and classification of recorded asset amount, or to amounts and classifications of liabilities that might be necessary should the company not continue as a going concern

(b) Income tax

No provision for income tax has been raised as the entity is exempt from income tax under Div 50 of the Income Tax Assessment Act 1997.

(c) Financial Instruments

Recognition and measurement

Financial instruments are initially measured at cost on trade date, which includes transaction costs when the related contractual rights or obligations exist. Subsequent to initial recognition these instruments are measured as set out below:

Financial assets at fair value through profit and loss

A financial asset is classified in this category if acquired principally for the purpose of selling in the short term or if so designated by management and within the requirements of AASB139: Recognition and Measurement of Financial Instruments. Derivatives are also categorised as held for trading unless they are designated as hedges. Realised and unrealised gains and losses arising from changes in fair value of these assets are included in the statement of comprehensive income in the period in which they arise.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in the active market, and are stated at amortised cost using the effective interest rate method.

Held-to-maturity investments

These investments have fixed maturities, and it is the Company's intention to hold these investments to maturity. Any held-to-maturity investments are stated at amortised cost using the effective interest rate method.

(c) Financial Instruments

Available-for-sale financial assets

Available-for-sale financial assets include any financial asset not included in the above categories. Availablefor-sale financial assets are reflected at fair value. Unrealised gains and losses arising from changes in fair value are taken directly into equity.

Financial liabilities

Non-derivative financial liabilities are recognised at amortised cost, comprising original debt less principal repayments and amortisation.

Fair value

Fair value is determined based on current bid prices for all quoted investments. Valuation techniques are applied to determine the fair value for all unlisted securities, including arms-length transactions, reference to similar instruments and option pricing models.

Impairment

At each reporting date, the directors assess whether there is objective evidence that a financial instrument has been impaired. In the case of available-for-sale financial instruments, a prolonged decline in the value of the instrument is considered to determine whether impairment has arisen. Impairment losses are recognised in the statement of comprehensive income.

(d) Impairment of assets

At each reporting date, the directors review the carrying values of tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the assets value, less costs to sell and value in use, is compared to the assets carrying value. Any excess of the assets carrying value over its recoverable amount is expensed to the statement of comprehensive income.

(e) Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks or financial institutions, other short term highly liquid investments with original maturities of three months or less, and bank overdrafts.

(f) Revenue

Revenue from the sale of goods is recognised upon the delivery of goods to customers.

Raffles revenues are recognised when the respective raffles are drawn and the amounts have been received from customers. Raffle ticket entries are issued once the pledged amount is received. It is not possible for the Company to reliably estimate the number of pledges that will result in raffle tickets being issued in each competition.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

Donation and bequest revenues are recognised when the Company receives the amounts pledged.

All revenue is stated net of the amount of goods and services tax (GST).

(g) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances, the GST is recognised as part of the cost of acquisition or the asset, or as part of an item of expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

Cash flows are presented in the statement of cash flows on a gross basis, except for the GST component of investing and financial activities, which are disclosed as operating cash flows.

(h) Financial income and expenses

Financial income comprises interest income on funds invested that are recognised in profit or loss. Interest income is recognised as it accrues in profit or loss, using effective interest method.

Accounts payable and other payables

Accounts payable and other payables represent the liabilities outstanding at the end of the reporting period for goods and services received by the Company during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

(j) New standards and interpretations not yet adopted

A number of new standards, amendments to standards and interpretations are effective for annual reporting periods beginning after 1 July 2018, have not been applied in preparing these financial statements. None of these are expected to have a significant effect on the financial statements of the company.

Basis of opinion

It should be noted that the accounting records and data relied upon for reporting on fundraising appeal activities are not continuously audited and do not necessarily reflect after the event accounting adjustments and the normal period-end financial adjustments for such matters as accruals, prepayments, provisioning and valuations necessary for period-end financial report preparation.

Emphasis of Matter

Without qualifying our opinion, we draw attention to Note 3 (a) in the financial report which indicated that the company had a working capital deficiency of \$83,952, recorded a surplus of \$5,094 for the year ended 30 June 2019, together with a net deficiency in assets amounting to \$163,952. These conditions indicate the existence of material uncertainty which may cast doubt about the company's ability to continue as a going concern.

Responsibilities of the Directors for the Financial Report

The directors of the Company are responsible for the preparation of the financial report that gives a true and fair view in accordance with Australian Accounting Standard – Reduced Disclosure Requirements and the Corporations Act 2001 and for such internal control as the directors determine is necessary to enable the preparation of the financial report that gives a true and fair view and is free from material misstatement, whether due to fraud or error. In preparing the financial report, the directors are responsible for assessing the Company's ability to continue as a going concern, disclosing as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the Company or to cease operations, or have no realistic alternative to do so.
